Origin of the Society

The genesis of the Society can be traced to the Chicago Council on Foreign Relations (now renamed as the Chicago Council on Global Affairs) which was addressed by Former President of Pakistan General Pervez Musharraf and its information on the web inspired Mr. Ahsan Mukhtar Zubairi, now the Secretary General and CEO of the Karachi Council on Foreign Relations, to make a council on the same lines. He found many intellectuals in the city agreeing with him. They all felt that there was a need for such a society which would not only be beneficial for Pakistan but for many other countries. For one thing there was a need for such a forum. As such 19 persons who are known as the founding members of Karachi Council got together and after long deliberations, formed the Karachi Council on Foreign Relations. The Council was formally inaugurated on 10th May 2003 in Karachi.

About us

The Karachi Council on Foreign Relations (KCFR) was registered as a society with the object of facilitating good relations between Pakistan and the representative of foreign countries based in Pakistan. The Karachi Council is a Pakistani based non-profit international organization and serves the community in Pakistan through diversified programming. The Karachi Council provides members with specialized group and the general public with a forum for the consideration of significant international issues and their bearing on Pakistan's foreign policy.

Members of KCFR comprise of a cross section eminent persons from all walks of life and include former Chief Justice of Pakistan, former Governor of Sindh, retired judges, retired military/naval/air force chiefs, retired diplomats, professionals, corporate executives, bank's presidents, businessmen and academicians. Each member is a leader in his own field of work or specialization.

KCFR regularly arranges talks and meetings with foreign visiting dignitaries as well as Ambassadors / High Commissioners and Consul Generals / Deputy High Commissioners of countries based in Islamabad and Karachi. This gives the members an opportunity of understanding their points of view as well as information on the state of existing relations with foreign countries who they represent and development of relations including travel with such countries.

The Council has already been addressed by renowned personalities including Mr. Shaukat Aziz (former Prime Minister of Pakistan), Mr. L.K. Advani (Former Deputy Prime Minister of India), Mr. Mike O'Brien (former British Minister of Foreign and Commonwealth Affairs), Mr. Douglas Alexander (former British Minister of Foreign and Commonwealth Affairs), Mr. Khurshid Mahmood Kasuri (former Foreign Minister of Pakistan), Mr. Jaswant Singh (former Foreign Minister of India), Mr. Shiv Shankar Menon (National Security Adviser to the Prime Minister of India) and ambassadors / high commissioners from different countries like France, India, Bangladesh, Sri Lanka, China, Afghanistan, Nepal.

The Council's importance is growing very fast specially after the signing of MoUs with the Egyptian Council for Foreign Affairs and Nepal Institute for Policy Studies and expected signing of MoUs with the Indian Council of World Affairs and Lakshman Kadirgamar Institute for International Relations and Strategic Studies.

Message from

Chief Justice (Retd.) Saiduzzaman Siddiqui

Patron and Founder Chairman of KCFR

The Karachi Council on Foreign Relations was originally founded as an apolitical, non commercial and a neutral think tank forum to provide an intellectual, in depth and objective discussions on issues touching the policy making of the state on subjects like foreign relations, economic affairs and law. It was established at a time when the Country was reeling under a Military Dictator which has overthrown a duly elected Civilian Government. Despite odds, difficulties and sensitivities of the Military Government, the Council invited the then Foreign Minister of Pakistan (Mian Khursheed Mahmood Kasuri) at the inaugural ceremony of the Council as its Chief Guest on 10th May 2003 in a local hotel at Karachi who very kindly accepted the invitation.



The Karachi Council had within its purview a research oriented program by arranging discussions, seminars, talk shows, question and answer sessions and inviting outstanding national and international personalities, academician and scholars to express their views on issues like foreign relation, economic affairs and law with the object of diffusing knowledge, providing help and guidance to the policy maker and awareness amongst the masses in a completely free and fair atmosphere.

The Council's ultimate goal was to promote a sense of respect and commitment amongst the rulers and the ruled to the rule of law in the society and propagate the concept of good governance in the country. The response received from the intelligentsia of the Council within a very short period of the establishment of the Council was very encouraging and with the passage of time the Council grew into a strong and independent institution for expression of unbiased and upright opinion on issues of national and international importance.

For its first three years of existence, I as the Founder Chairman of the Karachi Council tried my best to uphold the independent character of the Council which perhaps did not go well with the Government of the day. I finally made room in 2008 for another person to be elected as the Chairman of the Karachi Council. After I ceased to hold the office of Chairman, the Members of the KCFR very kindly elected me as the Patron of the Karachi Council.

In later years, the Karachi Council elected to confine its activity only in the field of Foreign Affairs as is apparent from its transformation from Karachi Council on Foreign Relation Economic Affairs and Law to Karachi Council on Foreign Relations. Despite the change in the name of Council, it continued to address vital issues of economics and good governance. The Council during 10 years of its existence has made great strides to advance the objectives enshrined in its Articles of Association and has earned a respectable name and stature among the foreign delegates and intellectual of the Council for its independent and unbiased analysis of the issues confronting the Nation.

While eulogizing the role of KCFR in educating the public opinion on issues of public importance, I would like to place on record that role of such think tanks need not be over emphasized as in all civilized countries of the world, the role of such societies is considered vital for formalizing state policies and to advance the concept of good governance.

The message will not be complete without mentioning the role played by the Secretary General of the Council, Mr. Ahsan Mukhtar Zubairi who conceived the idea of Council and transformed it into one of the foremost think tanks of Pakistan. I hope the Karachi Council will continue to discharge its assigned role undeterred by adversities.

Message from Barrister Liaquat Habib Merchant

Chairman and Founder Member of KCFR

I was elected as Chairman of Karachi Council on Foreign Relations (KCFR) as successor to two very eminent citizens of Pakistan i.e. Justice (Retd.) Saeed-uz-Zaman Siddiqui, former Chief Justice of Pakistan and Lt. Gen. (Retd.) Moinuddin Haider HI (M), former Governor of Sindh and former Interior Minister of Pakistan. Their leadership qualities and work have enabled KCFR to establish itself on a firm foundation on the way forward to achieving the objects for which KCFR was established.

KCFR has been in existence for 10 years and its members which comprise of Judges, Diplomats, Professionals, Businessmen, Industrialists, Bankers and Journalists have seen several years of authoritarian regime followed by 5 years of civilian Government elected through a democratic process. Events in Pakistan over the past 10 years have been very significant and have made an adverse impact on the security and financial independence of the country. While living through these critical times, the



members of KCFR have made endeavours to promote and maintain friendly relations with foreign countries through their diplomatic representatives in Pakistan and this has largely contributed to a positive image of the country in spite of set-backs on many fronts.

Pakistan has a geo-strategic location which is of vital significance. Pakistan has borders with India, Iran, Afghanistan and China all of which attract attention in the world of today. Pakistan has access to international waters as well as to the Gulf making it possible to have good trade relations with Oman and UAE and to the Gulf and overland with Iran, India, Afghanistan and China.

Relations with India have seen variations in view of the longstanding unsettled issues inherited by both countries as a result of partition of the Sub-Continent in 1947. Efforts are being made by the Governments as well as non-governmental organizations on both sides of the border to create conditions for peace, harmony and goodwill leading to free trade, travel and commercial relationship between the people of the two countries with the hope that public opinion on both sides will ultimately prevail on the respective Governments to ensure and implement policies which will lead and maintain peaceful and friendly relations between the two countries.

Pakistan's relationship with Afghanistan is at different level and dependent largely on American involvement and its ultimate withdrawal from Afghanistan in 2014. The vacuum which will be caused by US withdrawal will have its own repercussions which Pakistan will have to deal with and face.

On another front Pakistan faces threat from extremism and other radical organizations and dealing with these issues has taken up a large amount of time and effort on the part of Governments in Pakistan. These will continue as inherited problems for future Governments in the country. Pakistan's right to trade with Iran must not be impaired by the views of other countries in relation to Iran.

Pakistan is at the cross route once again this year and only time will tell what results the 2013 elections will bring to the forefront but the nation hopes that a democratic process will be followed and a democratic dispensation will remain. A peaceful transfer of power from one Government to another Government elected through a peaceful democratic process will go a long way in making Pakistan acceptable to the world at large as a country which they can deal with, trade and invest. Pakistan needs to look within and implement policies which are in its national interest. Closer cooperation with immediate neighbours and SAARC countries is the need of the hour.

Each member of KCFR is a leader in his or her own field of work or practice. However, KCFR has some way to go in establishing itself as an undisputed and legitimate independent think-tank in the country which is capable of not only expressing views on issues of national interest including foreign policy and foreign relations but also moulding public opinion on these issues.

It is my earnest desire to complete my tenure as Chairman at the end of 2013 with the hope that KCFR will continue to grow from strength to strength and play its part in the growth and development of Pakistan keeping in mind that Pakistan, according to its founder, Muhammad Ali Jinnah, is "a moral and intellectual achievement".

This Council was inaugurated on 10th May 2003and registered as a society with the object of facilitating good relations between Pakistan and the representatives of foreign countries based in Pakistan.

Members of the KCFR comprise of a cross section eminent persons from all walks of life including the former Chief Justice of Pakistan, former Governor of Sindh, retired judges, retired military/naval/air force chiefs, retired diplomats, professionals, corporate executives, bank presidents, businessmen and academicians. Each member is a leader in his own field of work or specialization.

The Karachi Council regularly arranges talks and meetings with foreign visiting dignitaries as well as ambassadors / high commissioners and consuls general / deputy high commissioners based in Islamabad and Karachi. This gives members an opportunity of understanding their points of view as well as information on the state of existing relations with countries which they represent, and the development of relations with such countries, as well as travel to these countries.

The Council is playing its due role in promoting regional cooperation by inviting ambassadors/high commissioners from SAARC, Latin America, ASEAN, Africa and the European Union to deliver lectures in Karachi. So far, the Council has invited 104 ambassadors / high commissioners from Islamabad to address the Council in Karachi. Twice the Council has been addressed by the Ambassadors of SAARC countries and the last event was held in Karachi on 12 November 2007 when KCFR organized an excellent event; a seminar on "SAARC: Prospects and Challenges". The Council was also addressed by the Latin American Heads of Mission in June 2008 and ASEAN Ambassadors / High Commissioners in July 2010.

The Council has also been addressed by Mr. L.K. Advani (former Deputy Prime Minister of India), Mr. Jaswant Singh (former Foreign Minister of India), Mr. Mike O'Brien (former British Minister of Foreign and Commonwealth Affairs), Mr. Douglas Alexander (former British Minister of Foreign and Commonwealth Affairs), Ambassador Mohammed Mijarul Quayes, Foreign Secretary of Bangladesh.

On the 9th anniversary of KCFR, which was celebrated on 7th May 2012, H.E. Mr. Rodolfo J. Martin-Saravia, Dean of the Diplomatic Corps and Ambassador of Argentina led a high level diplomatic delegation comprising 12 ambassadors / high commissioners from Islamabad representing European Union, SAARC, Latin America and ASEAN countries. The New Zealand High Commissioner came all the way from Tehran to attend this important event. Mr. Nisar Ahmed Khuhro, Speaker Sindh Assembly was the chief guest.

The Council realizes the importance of high quality research on international, regional, bilateral and domestic issues. Therefore, the Council published "WTO and Pakistan: An Overview", "SAARC: Prospects and Challenges" and "Reminiscences of a Pakistani Diplomat". Our forthcoming publication is "Indo-Pak Peace Process: The New Realities".

The Karachi Council is also committed to research oriented consolidation of relations between Pakistan and international community. In its humble capacity, the Council has started research wings that would improve the image of Pakistan and address the concerns of the international community in relation to Pakistan, especially in the post 9/11 era where there is lot ambiguity and opaqueness about the role of Pakistan in the war against terror in spite all of its sacrifices. Also the fact that probably Pakistan is one of the most important countries in the region when moving towards peace and tangible solutions in Afghanistan.

The KCFR would like to focus on research which may be factored in policymaking both inside and outside Pakistan, in the following:

- * Regional Integration of South Asia, with special focus on Pakistan-India Relations, which are now moving in a trajectory which must be strengthened and sustained
- * Pakistan's relations with the European Union. The EU sees Pakistan as a key ally in issues such as counter terrorism and the war in Afghanistan but this vision has not yet been translated into concrete policy. The relationship has a lot of untapped potential including the areas of development assistance, counter terrorism and trade. Pakistan should be in a strategic partnership with the EU.
- * Pakistan's relations with ASEAN. The efforts to raise the level of cooperation between ASEAN and Pakistan have gained new impetus towards identifying the tremendous potential and opportunities of joint collaboration. ASEAN countries highly value Pakistan's cooperation and interest in promoting friendly relations with ASEAN countries with its "Look East Policy".

I am extremely thankful to H.E. Mr. Rodolfo J. Martin-Saravia, Dean of the Diplomatic Corps and Ambassador of the Republic of Argentina, the Ambassadors / High Commissioners in Islamabad and the heads of the diplomatic missions in Karachi for their continued patronage and support in organizing the events of the Karachi Council.

I am really grateful to the Founder Chairman, Justice (R) Said-uz-Zaman Siddqui, immediate past Chairman, Lt. Gen. (R) Moinuddin Haider, current Chairman Barrister Liaquat Habib Merchant, members of the Board of Governors, all the members and staff of the Council for their cooperation in running the affairs of the Council.



Germany - Pakistan Relations



(Abbreviated version of the speech of the German Ambassador delivered at the interactive session on "Germany-Pakistan Relations" organized by the Karachi Council on Foreign Relations on 14th February 2013)

I would like to share with you some thoughts about the past, present and also the future of the relations between our two countries.



man - by German philosophers and writers such as Nietzsche and Goethe. He was well aware of the traditional interest of German writers and philosophers for the languages, the cultures and the religions of the subcontinent.



For Germany and for our government, "Culture" has always been a significant part of our Foreign Policy. When others reduced their presence in Karachi, the Goethe-Institut remained open - despite the number of challenges in Karachi. And because of this approach, the German Government is happy to be the main supporter of the 2013 Karachi Literature Festival.

Our two countries were never opponents in wars and don't share a history of conflict. This is probably one of the main reasons why Germany's assistance to Pakistan since the creation of Pakistan in 1947 and the foundation of the Federal Republic of Germany in 1949 could always rely on the support of all political parties in Germany and also of the German people.

In the last fifty years, Germany invested in the field of Development Cooperation in Pakistan roughly 2.3 Billion Euros. Pakistan can count on the support not only of the German Government but also of ordinary citizens. When huge floods had devastated all provinces of Pakistan in 2010, the response to the appeal for donations started by the German Public Television was overwhelming. Donations came from average TV-viewers who certainly never had been to Pakistan but who understood the necessity to help in such a dramatic situation. An amount of 200 Million Euros was raised within weeks.

When I was in the capital of Balochistan, in Quetta, I inaugurated a project for clean water (on 10th January 2013), financed by the KfW-Development-Bank. It provides clean water to over 20.000 families. The local community is now responsible for its functioning.

The same day I visited the Children's' Hospital in Quetta, largely funded by German donors and the only one providing high quality facilities between Karachi and Kabul. Every single day, this hospital saves lives of children and their mothers. It was erected with money from Germany but it works only because of the dedication of Pakistani doctors, nurses and other personnel.

Many other examples could be listed in all four sectors of the German-Pakistani Development cooperation: Energy, Health, Good Governance and Education. Let me share some examples with you.

Our Development Agency GIZ is supporting the textile industry in Faisalabad in its endeavours to save energy - Three

regional hospitals have been constructed and equipped in South Waziristan, Orakzai and Khyber and an initiative for vocational training has been started here in Sindh.

In this context I would like to emphasize one point: All these projects are seen not as help or donations in the traditional sense but as measures that ensure that the people can make something out of it.

All support from abroad - as important as it is - has to be seen primarily as a contribution to Pakistani initiatives. And we probably all agree: It is the economy who lies at the heart of Pakistan's development. Only a strong and dynamic economy can lead to a future where every Pakistani will get his or her decent share of the whole.

Germany as a big trading nation has always considered trade as the best form of cooperation between countries. Pakistan, this huge country of 185 million people, is a partner at which many foreign economic actors are looking with interest. Which company would not like to be engaged in such a huge market, keeping in mind a skilled and motivated labour force and looking at the geographical position of your country, a neighbour of India and China?

Many German companies do indeed ask us about investments in Pakistan. They keep repeating the same questions. For them three things are crucial:

- (I) Rule of Law and political stability
- (2) Security
- (3) Energy

These topics have to be addressed in a way that foreign investors get the guarantee they are longing for: Every Euro invested in Pakistan is a Euro that should flourish and multiply.

Looking at our bilateral trade in 2012, it has grown by 10 per cent which is far more than the growth of world trade which was around 3.5 per cent. Our bilateral trade, the biggest among EU partners, totalled 2.3 billion USD last year. I don't have to underline that there is much room for further growth and improvement. Karachi, its big harbour and the companies based here would particularly benefit from any trade increase. Therefore, the Embassy in Islamabad and the Consulate General in Karachi are strongly engaged to foster our relations in this important field.

Let me add in this context the great importance of the relations between Pakistan and the European Union. Germany as the largest economy within the European Union (EU) has an interest in seeing the EU engaging with Pakistan in the fields where the Union's competences lie. This is particularly the case in foreign-trade-relations. As you know, the individual member states of the EU have delegated the right to negotiate trade-agreements to the EU Commission in Brussels, this includes the so-called GSP plus-scheme. The German Government is a supporter of this scheme, not only because we think that developing our trade is the most beneficial form of cooperation but also because we like to contribute in any possible way to the stability and the wellbeing of Pakistan.

Looking at our bilateral cooperation I would like to highlight another particularly bright but often overlooked aspect: Our cooperation in the education sector.

A few years ago the number of Pakistani students who would choose Germany was negligible. This has changed tremendously. More than 2000 young Pakistanis are currently studying at German universities in the footsteps of Allama Iqbal. 500 of them have grants from the Higher Education Commission of Pakistan, from the German Academic Exchange Service (DAAD) or from other German institutions. Germany is an increasingly attractive destination for Pakistani students who can benefit from the best universities in Europe which - as you probably know - are also free of charge for everybody. The German language has only recently been introduced into the Pakistani school system. By now in the framework of the Partner School Initiative more than 2000 Pakistani pupils are studying the language in all big cities of Pakistan. As we started from scratch this is indeed a tremendous success story.

It is now time to come to the political framework of our relations. Last year (in 2012), Pakistan and Germany signed a strategic partnership. I know that the word "strategic" tends to be overused. In our bilateral case it means not only that there are regular meetings at a high political and administrative level but it also means - and this is equally important that we focus on the development of our relations in the sectors of trade, education, climate change, best practices and dialogue of the cultures. This means that specific goals are to be agreed on and that these goals will be then implemented. We are speaking of a very pragmatic and issue-driven common agenda.

In the eyes of Germany's decision makers but also according to the German media, the importance of Pakistan - not only as a partner - but also as a regional power has significantly grown over the last years. Everybody acknowledges that without the cooperation of your country with its huge population and resources and also with its significant armed forces peace cannot be achieved in the region.

Particularly important are good and stable relations between Pakistan and India. Germany welcomes the commitment of the Pakistani Government to build bridges between both neighbours. The mature and responsible reaction of Pakistan's Government after the most recent incidents at the Line of Control was perceived positively in Berlin.

The example of the European Union shows that practical measures such as liberalization of trade and opening borders for travellers can be a good starting point for the redefinition of our neighbourhood. As a nation we are dependent on open borders. Germany has also experienced the beneficial effects of free-trade-agreements. Without any doubt Pakistan would become an interesting destination for investors once the goods produced here can also be sold at the same conditions in the markets next door.

Germany maintains a force of 4500 soldiers in Afghanistan. In their zone of responsibility, in the north of Afghanistan, progress in terms of security and development can be seen. If you had the opportunity to travel to Mazar-e-Sharif recently you will have seen the new airport, the new regional hospital in a city which is bustling.

Nevertheless, at the end of 2014 ISAF troops will leave the country. This is also true for the German soldiers. Even after their departure we will continue to be committed to help Afghanistan on its way to Stability. In this context the role of Pakistan, Afghanistan's most important neighbour is crucial. With Pakistan as a partner and with Afghanistan's ownership of its future, it is possible to envisage a development towards stability in the whole region. Our commitment towards Afghanistan is therefore a contribution for regional stability.

It is only roughly seven months ago (Ambassador Nunn presented his credentials on 12th July 2012) that my family and I arrived in Islamabad. I would be lying if I said that I have already grasped all the complexities and nuances of Pakistan. What I can tell you without any doubt is that I am fascinated by your great and beautiful country.

Appeasing the Collective Conscience

I had just boarded a flight when a TV channel called me on the mobile to ask my reaction to the hanging of Afzal Guru. I did not know till then that he had been strung up to die. I instinctively replied that I felt saddened. It is a comment that is likely to haunt me for many well-wishers have asked me why I did not hold my tongue or tailor my remark to the popular mood, for it seems that there is national rejoicing at the hubris that has overtaken those who sought to end our democracy in one fell blow on Parliament.



It may have been an instinctive reaction but it reflected my deeply held abhorrence at the death penalty. I had certainly articulated the same position when Nalini was spared the death sentence for her part in the assassination of my friend and patron, Rajiv Gandhi. I had felt relief then that we were not taking a life to punish the taking of a life, even the taking of the life that was the staff of my life; my belief that all life is infinitely precious, howsoever misused; that to imitate assassination by assassination is to become complicit in assassination. I had felt the same when I heard of Ajmal Kasab's hanging, with this one difference - that Kasab had sought martyrdom when he embarked for Mumbai, and the Indian State was helping him realize his most ardent desire. Afzal Guru sounded resigned to his Fate, rather than welcoming it.

Revenge is not justice. For revenge often engenders counter-revenge. That is why so many terrorists are born in the crucible of the injustice they see themselves being subjected to, or believe they have been subjected to - whatever the facts of the case. So, putting them away - for all of their natural life in high security prisons in the "rarest of rare" cases - is a reasoned response to terrorism. But leaving them dangling in the air is almost certain to be fertile breeding ground for more terrorism.

As for the hanging of ordinary murderers - as distinct from ideological murderers - the record seems to show that the death sentence is hardly ever a deterrent. That is why a vast majority of countries, some 139 of the member-States of the United Nations, have abolished the death sentence. They have discovered that murderers, whether ideological like terrorists or personal like killers, tend to be either schizophrenic or psychotic or both, neither being a category that yields to the common fear of retribution, especially final retribution. Even in cogent moments, the psychopath is likely to regard the risk of death in inflicting death as a risk worth taking. Perhaps that explains why in the United States, where it is State law rather than Federal law that prevails, those States that have retained execution tend to have higher murder rates while States that have abolished execution by the State have lower murder rates.

The nexus between awarding the death penalty and deterring crime was discredited centuries ago with the saying that one might as well be hung for a sheep as a lamb. The origins of that expression lie in 17th-18th century England where almost every crime was punishable by public hanging - and so the highwayman consoled himself with the profitable thought that if one were anyway going to be hanged for stealing a lamb, one might as well steal the whole sheep. The relationship between death and deterrence has never been established. This explains why our Supreme Court has long held that death may be awarded in only the "rarest of rare" cases.

Except, of course, in Afzal Guru's case. There, the Supreme Court confirmed that the only evidence led against Afzal Guru was "circumstantial", that is, uncorroborated by other evidence which would link him to the heinous crime. Yet, decided the learned judges, death would be the appropriate condign punishment to salve the "collective conscience of the nation". Certainly, this was the rarest of rare judgments. Challenging the collective conscience of the nation is an everyday occurrence in a vibrant democracy. It is perhaps the highest duty of the public intellectual. There would have been little human progress without radical challenges to the received wisdom that constitutes the collective conscience of any nation.

But I felt saddened at Afzal Guru's hanging not primarily because it might constitute a grave miscarriage of justice but because I am perforce part of a system that considers the taking of human life as "justice". When someone dies at my hands, at least in the constructive sense, that makes me complicit in death by strangulation. I am diminished as a human being. For, as John Donne sang centuries ago, "Ask not for whom the bell tolls/It tolls for thee".

Interactive session on "Germany-Pakistan Relations" with H.E. Dr. Cyrill Jean Nunn, Ambassador of the Federal Republic of Germany

The Ambassador of the Federal Republic of Germany in Pakistan, H.E. Dr. Cyrill Jean Nunn was invited by the Karachi Council on Foreign Relations on 14th February 2013 to speak at an interactive session on "Germany-Pakistan Relations". The event was organized at the Frere Hall in collaboration with Pakistan-German Business Forum (PGBF).

H.E. Dr. Cyrill Jean Nunn thanked the Board of Governors of KCFR for the opportunity to address the prestigious "Karachi Council on Foreign Relations". He said that it is always a great pleasure for him to be in the "City of Lights"

(i.e. in Karachi) which is the commercial centre of the country.

Dr Cyrill Jean Nunn lauded Allama Iqbal's poetry saying that the great poet of Pakistan had studied in Germany as he was inspired by the German writers and philosophers, culture and traditions. Now, more than 2000 Pakistani students are following Allama Iqbal as they are studying in Germany with the support of German and Pakistani Governments.

Dr. Nunn said that Pakistan and Germany enjoy deep-rooted relations that have been built-up during the last 50 years and Germany had supported Pakistan in various sectors throughout this period. He further said that as many as 2.3 billion Euros have been invested by Germany in Pakistan in the field of Development Cooperation.

The German Ambassador said that Germany believed only strong economy can lead any nation or country to bright future and he desires

the same for Pakistan. The Ambassador shared that for the past 50 years, Germany had invested considerably in the development support of Pakistan. In this regard, the German Government has established three hospitals in South Waziristan and was helping to revamp the textile industry in Faisalabad.

Dr. Cyrill said that Germany supported Pakistan during the devastating floods of 2010 and funds amounting to 200 million Euros were raised by the Germans for their Pakistani brothers and sisters just within a week. He continued that the German Government is working for provision of clean drinking water, education and health facilities to the people of Balochistan, Sindh and Khyber-Pakhtunkhwa.

Ambassador Nunn further said that Germany had assisted Pakistan in climate change, textile, education, good governance and many other sectors. He added that Germany will establish a university in Islamabad which would provide education to the students on Climate Change and other subjects.

The German Ambassador highlighted that Germans were close to Pakistanis because they also shared a common experience of living in conflict. He stressed that security, political stability and energy were the three things that German investors look for in Pakistan before thinking if making investments.

Regarding the composition of trade between Pakistan and Germany in 2012, German Ambassador said it increased 10%, which is far more than the global growth rate which is around 3.5%. However, he noted that the trade in textiles between the two countries witnessed a decline in 2012.

Coming to the political framework, the German envoy reminded the audience that his country and Pakistan had signed a strategic partnership agreement last year (2012) and that this meant pursuing a "pragmatic and issue-driven agenda". He described Pakistan as a "regional power" and said that without this country, there could not be peace in this region.

Throwing light on Germany's foreign policy, the Ambassador said that the primary goal of German foreign policy is to preserve peace and security in the world. The expanded concept of security covers not only questions of conflict

prevention, defense, disarmament and arms controls but also economic, ecological and social issues as well as human rights.

Commenting on the recent flare-up (in the first week of January 2013) with India over the reported killing of troops across the Line of Control, Ambassador Nunn said Pakistan displayed a "mature response" in reaction to the crisis and that it was well-received in the European Union. He hoped to see both India and Pakistan live peacefully. Dr Cyrill further said that peace in the South Asian region was top priority of Germany, as cordial relations between India and Pakistan were important for region's peace.

As for Afghanistan, the Ambassador said Germany is a strong and reliable partner in the international efforts to help build an Afghanistan that will never again become a haven for terrorists. A responsible handover to Afghan authorities is the guiding principle of German foreign policy and Germany has been thoroughly

committed to the stabilization and reconstruction of Afghanistan, building on historically strong bilateral German-Afghan relations and decades of German reconstruction assistance. The Ambassador informed that while Germany currently had around 4,500 troops in Afghanistan, these forces would pull out with the other ISAF forces at the end of 2014.

Replying questions of the participants during question and answer session, the German Ambassador said he was happy that the Government of Pakistan had incorporated German language in its academic books in many institutions.

To a question about drone attacks in Pakistan, he said that despite the fact that Germany was biggest economy of Europe, it could not influence the US and can't stop the drone attacks.

Replying to another question, the Ambassador said granting the Generalized Scheme of Preferences-Plus (GSP+) status to Pakistan will be primarily a "political decision" aimed at boosting Pakistan's economy. Ambassador Nunn warned that there were some countries within the EU that wanted to protect their markets from Pakistani textile imports as they are not "naturally favourable" to their economies. Explaining that Germany is not a negotiator in the matter of the GSP+ scheme, Dr. Nunn said his country would use its influence to negotiate a package that suits the two parties.

Barrister Liaquat Habib Merchant, Chairman of Karachi Council on Foreign Relations welcomed the German Ambassador for accepting the Council's invitation to address the members of the KCFR and the PGBF. Mr. Merchant said that the KCFR is the organization which comprises of a cross section of leaders from different walks of life including retired judges, ex-diplomats, academicians, retired military/naval/air force chiefs as well as civil servants.

As in this year of 2013, France and Germany celebrated the 50th anniversary of Élysée Treaty (also known as the Treaty of Friendship), which was established by Charles de Gaulle of France and Konrad Adenauer of Germany on January 22, 1963 for reconciliation between the two countries, Mr. Merchant discussed the importance of this Treaty.

Mr. Merchant said that Pakistan and India can live in peace and harmony and be very good neighbors if they follow the Elysee Treaty as Germany and France established a new foundation for relations that ended centuries of rivalry between them. In his view, the Treaty of Friendship, which defined the organizing principles of the relationship between two century old enemies (i.e. France and Germany), was the result of political will and courage on both sides. He further said that the Treaty can be a role model for India and Pakistan not only because it institutionalized regular meetings between state representatives but also because it recognized the importance of civil society of France and Germany. He also informed the audience that the Karachi Council will organize an event on the significance of Élysée Treaty for India and Pakistan in 2013.

Earlier, Mr. Ahsan Mukhtar Zubairi, Secretary General and Chief Executive Officer of the Karachi Council gave an account of the German Ambassador's diplomatic career.

Mr. Zubairi informed the audience that the Ambassador joined the German Foreign Office in 1985. He served as Desk Officer - Western Balkans Division at the German Foreign Office from 1992-1995. He also served as Counsellor (Common Foreign and Security Policy) at the German Permanent Representation to the EU in Brussels - Belgium from 1995-1999. He held the position of Head of the European Division - Federal Chancellery from 1999-2002 and as Head of Export Controls Division at the German Foreign Office from 2005-2008. He was also appointed as the Deputy Head of the Minister's Office at the Federal Foreign Office from 2008-2009. Prior to his appointment as the Ambassador to Pakistan (since July 2012), he was serving as Director General for Asian and Pacific Affairs at the German Federal Foreign Office from 2009-2012.

Interactive session on "Italy - Pakistan Relations" with H.E. Mr. Adriano Chiodi Cianfarani, Ambassador of the Italian Republic

The Italian Ambassador in Pakistan, H.E. Mr. Adriano Chiodi Cianfarani was invited by the Karachi Council on Foreign Relations on 7th March 2013 to speak at an interactive session on "Italy-Pakistan Relations". The event was organized at the residence of Mr. Kalim Farooqui (Corporate and Board member of KCFR) in collaboration with the Italian Development Committee (IDC).

The event was also graced by H.E. Mr. Peter Heyward, High Commissioner of Australia along with his wife. The event was well attended by diplomats, academicians, the elite of Karachi, members of KCFR and IDC.

Ambassador Cianfarani first of all extended his sincere thanks to the Karachi Council on Foreign Relations and the Italian Development Committee for providing him an opportunity to address such an august gathering on the subject of Italy-Pakistan relations. The Italian Ambassador described bilateral relations with Pakistan as "excellent' and looking eager to develop it further as potentials were immense.

The Italian Ambassador said that both Italy and Pakistan shared common views on many key issues and Italy recognized the sacrifices Pakistan had rendered in the "War on Terror". He recalled his country's help in securing Pakistan a seat at the United Nations Security Council. Regarding Pakistan's relations with Italy, Ambassador Amin said that Italy and Pakistan have cordial relations. Italy is an active investor in Pakistan. Both Italy and Pakistan are in total consonance on political issues and have a desire to enhance

already existing close ties. Pakistan wants to develop deep-rooted and wide-ranging relations with Italy in all fields particularly in trade, commerce and economy.

Mr. Amin informed that in 2004, both countries celebrated the 50th anniversary of first assent to K-2 (the second highest mountain on Earth after Mount Everest) when an Italian expedition succeeded in ascending to the summit of K-2 on 31st July 1954. The expedition was led by Ardito Desio, and the two climbers who reached the summit were Lino Lacedelli and Achille Compagnoni.

KCFR Co-Chairman informed that Italy has been a major participant in Pakistan's scientific contribution to the world and both countries established the International Conference on Astrophysics and Relativity in 2011.
